Maharashtra Right To Public Services Act, 2015.

No. MIS-0615/C.R.59/Acts.—Whereas in exercise of the powers conferred by sub-section (1) of Section 3 of the Maharashtra Right to Public Services Act, 2015 (Mah. XXXI of 2015) (hereinafter referred to as "the said Act"), the Medical Education and Drugs Department by the Government and by Notification, No. MIS-0615/C.R.59/Acts, dated 27th July 2015 Notification, No. MIS-0615/C.R.59/Acts, dated 17th June, 2017 (hereinafter referred to as "the said Notification") notified the public services rendered by that department to eligible persons through its subordinate offices and authorities including the Commissionerate of Food and Drugs Administration, Mumbai, alongwith the Stipulated Time Limits for providing such public services, the Designated Officers and First and Second Appellate Authorities, as specified in the Schedule-I appended to the said Notification for the purposes of the said Act;

Now, therefore, the Government of Maharashtra in Medical Education and Drugs Department, in exercise of the powers conferred by sub-section (1) of Section 3 of the said Act, hereby amends the said Notification on full in the said Notification, in Schedule-I the following entry shall be added, namely:—
