Nursing (2 years), PBBSC Nursing (2 years) PB Diploma in Paediatrics Specialty Nursing (12 Months) & Post Basic Diploma in Psychiatric/Mental Health Nursing (12 Months) at the Institute of Nursing Education, Mumbai College of Nursing, College of Nursing, Government Medical College, Nagpur, and Maharashtra Institute of Mental Health Pune under the Directorate, Medical Education and Research, is being published for the academic year 2026 – 2027

1) General: Maharashtra University of Health Sciences, Nashik Affiliated M.Sc. Nursing (2 Years) admission process will be implemented by the Government at the following colleges.

The Government of Maharashtra vide Letter **No.MED/1026/म.प्र.179/2026/EDU-2 Dated 19.06.2026** Permitted to the Directorate of Medical Education Research, Mumbai to admit the eligible candidates for M.Sc. Nursing, P.B.BSc. Nursing, P.B. Diploma in Paediatric Specialty Nursing & Post Basic Diploma in Psychiatric/Mental Health Nursing for the academic year **2026 - 2027**.

2) Competent Authority, Nodal Officers and their functions:

2.1) The Admission process will be carried out through the Competent Authority and the authorized officers. The Director, Medical Education and Research, Mumbai shall be the competent authority in this regard and the institution wise Nodal officers are as follows:

2.2) Functions of Competent Authority:

The Competent Authority, through the nodal officers appointed by it, shall implement the admission process and control the selection process in accordance with the said rules and act as the appellate authority in this regard if the candidates make a report. The competent authority shall make necessary arrangements for the enforcement of these rules. The competent authority or the nodal officers appointed to present in the case of petitions filed in the Courts in this regard on behalf of the Maharashtra Government as per the instructions given from time to time.

Legal Jurisdiction:

All disputes pertaining to the selection process of all courses shall fall within the Jurisdiction of courts at Mumbai only. The Competent Authority shall be the legal person in whose name the Government of Maharashtra may sue or may be sued.

2.3) Function of Nodal Officers:

The Nodal Officers under the control of the competent authority will distribute the admission forms. Accept and scrutinize application forms and publish the merit list. If any candidate challenges the decision regarding admission in the court, in that case as well as directed by the competent authority from time-to-time, Nodal officers has to plead in Courts on behalf of the Government and/or Competent Authority.

2.4) Prescribed specimen application forms may be obtained from the respective institute.

2.5) Applications fully filled in all aspects should be submitted through proper channel by the in-service candidates under DMER/DHS on or before the date notified by the competent authority. Late applications will not be accepted at any condition. Private candidates will submit their complete fully filled form to the respective institute. Merit List will be displayed at respective institute by the Nodal officers.

2.6) Grievance Redressal Authority (All General): Any complaint regarding the admission process shall be dealt with by the Competent Authority / Nodal Officers.

3. Medical Certificate of Physical Fitness: Candidate must be physically and mentally fit to complete this course. Candidates should submit a Medical Certificate from the Civil Surgeon/Medical Superintendent of the Government Hospital regarding their physical fitness along with the application form in prescribed format (Annexure A). Also, Persons with Disabilities (Equal Opportunities, Full Participation and Protection of Rights) Act, 1995, Section 2 (T) As Per INC notification F.No.1-5/20018-INC dated 10.04.2019 for disable candidates reservation is considered with a disability of locomotor to the tune of 40% - 50% of the lower extremity.

4. Reservation:

4.1) Reservation for Reserved category candidates :

4.1.1) Reservation for Reserved category candidates are as follows :

4.1.2) Applicants for reserved categories (1) to (8) mentioned above must attach the Caste Certificate & Caste Validity Certificate from the competent authority with the application form.

4.1.3) The benefit of reservation shall not be admissible to the candidates belonging to the creamy layer groups of above (3 to 8) categories. However, it is mandatory to submit the Non Creamy Layer certificate from the competent authority valid up to **31/03/2027**. As per Government Resolution, Social Justice, Cultural Work and Special Assistance No.CBC.10/2008/Pra.No.697/ dated 16 December 2017, in revised prescribed format that they do not fall under the creamy layer category. Old Non-Creamy Layer Certificate will not be considered.

4.1.4) If the seats in the reserved category (1) to (7) remain vacant, shall be filled among the remaining reserved category according to their inter-se-Group-merit. If the seats still remain vacant then, these seats will be filled by Inter- se- Group merit from the General category candidates. **If the seats reserved for SEBC remain vacant, such seats shall be considered for allotment to the Candidate of general inter-se-merit.**

4.1.5) Reservation Inter-se Group will be as follows-

Group-1.

- a) SC : Schedule Caste and Schedule Caste converted to Buddhism (SC)
- b) ST (including those living outside the specified area)

Group-2.

- a) VJ- NT- A
- b) NT-B

Group-3.

- a) NT- C
- b) NT-D
- c) OBC Including SBC

4.1.4) While considering reservation category seats, reserved candidates who have been selected on merit (without benefit of reservation) such seats will not be counted for reserved seats.

4.1.5) If the seats in DMER/DHS candidates (Govt. Seats) mentioned in the distribution of seats for said courses remains vacant, shall be filled among remaining DMER/DHS candidate according to inter se group. If the seats still remain vacant these seats shall be filled by inter se group from private candidate in order to fulfill the government seats quota.

4.2 Reservation for candidates with disabilities (PWD) shall be indicated as below:

4.2.1) As per the provision of Revised Notification of Indian Nursing Council, New Delhi, No F-1.5/2018 /INC dated 10/04/2019, 5% reservation of total seats will be reserved for locomotor disability candidates. Any seats remaining will be reverted back to respective category.

4.2.2) Candidates applying for seats reserved for persons with disability must submit a certificate of their disability from the competent authority signed by Civil Surgeon/Medical Board of District General Hospitals/Medical Superintendent of Government Medical College and Hospital or Director, All India Institute of Physical Medicine and Rehabilitation, Haji Ali, Mumbai in the prescribed format. Candidates should attach the certified true copy of such certificate along with their application. **(Annexure-B)**. Disable candidate reservation is considered with disability of locomotor to the tune of 40-50% of lower extremity. Disability other than Locomotor is not allowed as per the rules. However, the verification of disability of the candidates will be done through a medical board constituted by the competent authority for this purpose.

4.3.Reservation for orphan candidates :

As per Government Resolution dated- 2.4.2018, 1% parallel reservation in open category will be applicable to the said candidate in education and employment. Accordingly, the candidates should submit the certificate from Department of Women and Child Development.

4.4) Reservation for Economically Weaker Sections (EWS):

As per Government Resolution No. 4015/P.No.3.2/16-A dated 12th February 2019, reservation of 10% to be given to the Economically Weaker Sections. Submission of certificate from competent authority in prescribed form **(Annexure-C)** shall be mandatory for availing reservation for Economically Weaker Section **(EWS)**.

4.5) As per Government Letter No. MED-1024/C.R./178/24/EDU-2 Dated 06/06/2024 Socially and Educationally Backward Classes (SEBC) & as per Maharashtra State Reservation for Socially and Educationally Backward Classes Act, 2024 published in the Maharashtra Govt. Gazette, Part VIII on 26th Feb,2024, reservation of 10% to be given to the SEBC

4.6) Reservation For Female Candidates

As per Government Resolution No.MED-1300/CR-271/2000/Shikshan - 1 Dated : 05 June 2000, 30% seats at the disposal of the Competent Authority shall be reserved for female candidates in PBBSc graduate course. This reservation will be operated in parallels. Female candidates will be first allotted female quota seats after exhausting female quota seat then female candidate will be allotted general seat as per merit. If requisite numbers of female candidates are not available , then these seats shall be offered to male candidates of that category.

5. Selection Process:

5.1) Provisional merit list of eligible candidates will be displayed on the notice board of office of the Principal of all the respective Nursing colleges. Objections raised by the candidates regarding provisional Merit List will be considered (with correction, if necessary) and will be published at the place specified above within a prescribed period mentioned in the schedule of Admission Brochure.

5.2) Eligible Candidates qualified as per merit list should report for counselling on given date as per Information Brochure with all original documents at Preferred Nursing Colleges.

5.3) The final selection list of the candidates selected on the basis of merit in the counselling process will be published at the place specified above. Selection orders will be issued to the selected candidates at the respective institute. **Selected candidates has to join on 01.08.2026,** Selected candidates vacant seats will be filled within the prescribed period from the waiting list according to the quota. The final decision regarding the selection process will rest with selection committee.

5.4) Candidates must submit the original documents immediately to the principal of the concerned institution at the time of admission. Also, the payment of the prescribed fee has to be paid subsequently by the selected candidate.

5.5) Final admission of selected candidate will be subject to the approval by Maharashtra University of Health Sciences, Nashik.

5.6) It is hereby clarified that, all candidates who do not appear at the Institute after selection or fail to comply with the necessary formalities within the prescribed time shall not be eligible to take admission for next two years. In case of cancellation of admission after the cut-off date of the University, the amount **Rs. 1,50,000/- (One Lakh Fifty Thousand only)** has to pay as a penalty for lapse of seat.

6. For In-Service Government Candidates:

According to Maharashtra Civil Service Leave Rules, 1981 Chapter Seven Study Leave (80 to 93)

In-service Government candidates procedure will be followed regarding study leave as per the provisions of Maharashtra Civil Service Study Leave Rules **80 to 93 of the Leave Rules, 1981**. The decision regarding study leave will be taken by the respective competent authority.

7) Admission forms will not be considered unless the following conditions are met:

7.1) Admission forms should be duly, accurately and completely filled.

7.2) Substantiation of the claim made in the application form should be accompanied by the true copies of all necessary certificates. Any admission application not accompanied by certified true copies will not be considered.

7.3) Application for Admission should be received at the office of the authorized Nodal Officer by the final scheduled date and time.

7.4) No such application shall be considered if the attested xerox copies of all necessary certificates are not attached with the application.

7.5) At the time of admission all necessary original certificates shall be handed over to the Principal of the concerned College. These original certificates will be returned to the candidates after completing the course or leaving the institution.

7.6) Photocopies of certificates submitted later for any reason after submission of admission application will not be accepted. Candidate should fill admission form properly and carefully.

7.7) Candidates who are currently serving in Government service must submit their applications through the proper channel (i.e., through the Head of the Institution/Office where they are employed), along with a Covering Letter and No Objection Certificate (NOC), to the institution where they seek admission. Candidates should not submit applications to the Directorate, nor send them by post, nor deposit them directly in the Directorate's mail. Applications received by the Directorate will not be considered, and candidates should take note of this. The Candidates of DHS (Commissioner/Director Health Services) should send their applications to the concerned institution for admission through their headquarters/prescribed channels. If there is any delay by the headquarters/ Candidates in submitting the applications of DHS Candidates within the prescribed time frame, the said applications will not be accepted and the entire responsibility will remain with the DHS Candidates.

8. Fees and Scholarships etc.:

8.1) The tuition fees for this course shall be as per the Government of Maharashtra from time to time.

8.2) Hostel facility will be depends on the availability of the accommodation. All the candidates may not get hostel facilities.

8.3) Selected candidates will have to pay the first-year course fees at the time of admission. Thereafter the prescribed fees have to be paid at the beginning of each academic year. Admission of candidates will be confirmed only after payment of admission fees.

8.4) Fees structure as per Government Decision No. AMC - 1007/628/P No. 148/07/Shikshan-2 dated 01 March 2011 and Letter no DMER-11011/9/2022-CETIT dated 06.06.2023.

Apart from the above fees University examination and other fees will be charged as per University & MSBPNE rules. Fees will remain permissible as per the orders of the Government from time to time.

8.5) Education fee waiver schemes such as, Schemes for Reserved Category, children of ex- servicemen, Primary/Secondary school teachers etc. will be admissible to the candidates as per the orders of the Government of Maharashtra in force from time to time.

8.6) The admission brochure and admission form fees for M.Sc. Nursing at INE, Mumbai, College of Nursing, GMCH, Nagpur & Maharashtra Institute of Mental Health, Pune will be **Rs. 2000/-** for open Category and **Rs. 1500/-** for reserved category. The same fees will be For P.B.B.Sc. Nursing. The fees for PB Diploma in Paediatric Specialty Nursing & Post Basic Diploma in Psychiatric / Mental Health Nursing will be **Rs. 1000/-** for open category and **Rs. 500/-** for reserved category.

9. Conduct and discipline for the students

9.1) It is mandatory for the selected candidate to pay the prescribed tuition fees in time.

9.2) It is mandatory to submit three different bonds namely Affidavit for Educational Gap, Affidavit for Laps of Seat and Affidavit for hundred percent Attendance along with all the original documents.

9.3) Admitted candidates shall be bounded by the relevant rules of conduct and discipline of the Institute and Maharashtra University of Health Sciences.

9.4) If any student is found to be involved in Anti-national activities against the provisions of the laws and regulations of the Government from time to time, the principal may rusticate the student from the institution without prior notice.

9.5) Selected candidates should not remain absent in the academic session. All absent candidates will be dealt with as per rules. However, in case of absent candidates in Government service, a written report will be sent by the institute to the concerned offices.

9.6) Any statement or information provided by the candidate in the application form is found to be false/incorrect at any time thereafter, his/her admission will be cancelled. The fees paid by him /her will be forfeited and he/she may be removed from the college by the principal and action will be taken against him/her as per Government rules.

9.7) The student involved in ragging after admission, he/she will be expelled as per the MUHS rules.

9.8) It is mandatory for the student to complete the PBBSC / MSC nursing course within 4 years and P.B Diploma in Pediatric Speciality Nursing – Residency program within 2 Years as per the norms of Indian Nursing Council, New Delhi, Maharashtra University of Health Sciences, Nashik and MSBNPE Mumbai.

10. Eligibility Criteria for MSC Nursing

10.1) The candidates having Indian citizenship will be eligible for admission and should be a resident of Maharashtra State. (Certificate of Nationality/Domicile must be attached.)

10.2) Maximum age limit will be **45** years for the General category and **50** years for reserved category as on **31 July 2026**.

11. Educational Qualification and Work Experience:

11.1) Candidate should have passed Higher Secondary Certificate Examination of Maharashtra State Board of Secondary Examination or equivalent examination recognized in Maharashtra State with English subject.

11.2) Candidates whose parents are natives of Maharashtra State, but the candidates have passed Secondary School Examination or equivalent and/or Higher Secondary School Examination from an institution outside the State of Maharashtra, such candidate is also eligible for admission, provided such candidates must submit original Domicile Certificate duly signed by competent authority.

11.3) Candidate should have passed the examination of Basic B. Sc. Nursing / P.B.BSc. Nursing/ P.B.BSc. (IGNOU) Nursing course must have passed from Institute / Study Centre recognized by Indian Nursing Council and Maharashtra Nursing Council.

11.4) Candidate should be registered as a Nurse and Midwife with Maharashtra Nursing Council is mandatory. Also, the said registration should have been renewed till March 2027 & MNC additional qualification certificate is mandatory.

11.5) It is mandatory for the candidate to have one-year work experience. Experience will be calculated from the date of registration with Maharashtra Nursing Council as Nurse and Midwife till **31/07/2026**.

11.6) Government In-service candidates must have completed five years of continuous Government service till **31/07/2026**. The candidate must submit a work experience certificate from the authority.

11.7) In-service candidates should submit their applications through proper channel only. A merit list will be prepared based on the applications received through proper channel within the prescribed time. Application Received late will not be considered. Also by post, Xerox or Photo copies of application will not be accepted.

12. Educational Qualifications to be considered for selection process:

12.1) The selection of candidates will be done on the basis of aggregate marks obtained in all years examination of Basic B.Sc Nursing / P.B.B.Sc Nursing / P.B.B.Sc Nursing (IGNOU). If the candidates get equal marks in under graduate course, the following procedure will be adopted to determine the inter merit in respect of them: –

Tie Breakers: -

12.2) First-Preference: Aggregate marks obtained by the candidate in the Higher Secondary School Examination (Std 12th) will be taken in to consideration while deciding the first preference.

12.3) Second-Preference: Aggregate marks obtained by the candidate in the SSC (Std.10th) will be taken in to consideration while deciding the second preference.

12.4) Third Preference: The candidate those who are senior by age will be given preference.

13) Clinical speciality will be issued as per the merit preference of the candidate and availability of seats. Final rights are reserved with Competent Authority.

14) Admission form and Documents to be submitted for M Sc Nursing.

All applicants must submit the attested true copies of following documents with the admission form:
